ALL STUDENTS ENROLLED IN 1st SESSION DRIVER EDUCATION MUST BE AT LEAST 14 YEARS OF AGE ON OR BEFORE MAY 26 or 2nd SESSION ON OR BEFORE JUNE 22.

Enrollment for Summer Driver Ed will be held at the same time as enrollment for next school year on February 10 and 12 from 3:15 pm - 8:00 pm. Enrollment for Summer Dr. Ed. will remain open until 52 students are enrolled in AM and 52 in PM classes (104). Any student may enroll until May 22 (1st Ses) or June 19 (2nd Ses.) **The reason we have a deadline for Dr. Ed. In case the State has any medical questions for any students and to get driving schedules mailed out.**

Students need to pick up an application form and have it completed before the enrollment dates. You will be able to pick them up at Campus Main Office or Counseling Office or the Middle School Counseling Office. **Students with parents will fill out the State FORM at the April 8 meeting in the Auditorium at Campus. They MUST have the application form filled out correctly with Parent AND Student signature to be legal.**

There will be a 2 day Defensive Driving Class Included in the Summer Class and anyone who already has a Driver's License may also enroll in this part only for \$20. They MUST have a DRIVERS LICENSE. First session dates for this is June 3 and 4; second session dates are July 9 and 10. These two days will meet for **3 hours** each day.

STUDENTS ENROLLING FOR SUMMER DRIVER EDUCATION MUST BRING THE APPLICATION FORM COMPLETED. YOU MAY SIGN UP FOR THE 7:30 TO 10:00 OR THE 12:00 TO 2:30 CLASS, BUT IF ONE CLASS IS FULL, (52 STUDENTS) STUDENTS WILL HAVE TO GO TO THE OTHER CLASS IN EACH SESSION.

After the students are enrolled and accepted, the following will be needed before the summer session begins:

1. **There will be an IMPORTANT meeting for all Dr. Ed. Students and a legal guardian on April 8, 2020 at 7:00 PM in Campus Auditorium.** The student and a **legal guardian** need to be present to make sure they understand their driving schedule and to answer any questions about Dr. Ed Course or Defensive Driving course. **We will also fill out the STATE FORM at this time.** The teacher will give instructions about how the class will operate at this meeting.
2. **WE PREFER THAT STUDENTS GET AN INSTRUCTIONAL PERMIT AT THE DMV BEFORE THE CLASS STARTS. Practicing with Parents before class starts is a PLUS. Driver Ed. is only five hours of driving.**
3. Students must have an eye test. Campus USD 261, will provide an opportunity for this at enrollment. If you have a **current** Instructional Permit as talked about in #2, you do not need another eye test.
4. After the 2 classes of each session are filled, we will put students who want to enroll on a waiting list.
5. **Fees will be \$250.00 for Driver Education and should be brought to Mrs. Solis in the main office at time of enrollment. Please be prepared to pay these fees when you enroll.**

1. Students will be in the classroom 13 days and each student will drive 5 days the week they are scheduled for driving.
2. You **CANNOT** miss any class time. In **EXTREME EMERGENCIES**, we will work out a makeup time IF possible. Church or athletic camps or family vacations are NOT considered EMERGENCIES! So be sure to choose the best class to fit YOUR SITUATION.
3. You **CANNOT** miss any scheduled driving times.
4. There will be **NO** refunds after May 22 for 1st Session and June 19 for 2nd Session.
5. **YOU MUST BRING A 3-RING NOTEBOOK, PAPER, PEN OR PENCIL TO CLASS.**
6. Driving will be in 2-hour blocks of time for 5 days in a row for one week (Monday-Friday), however, the first week we will drive Tuesday through Saturday. A Saturday may be used if needed for makeup due to weather or car breakdowns, etc. Students will be notified in advance if at all possible, if this happens.
7. If you presently have an instructional permit (DMV) to drive, please keep it current until your driver education class is completed. This permit could be used during driver education class.
8. **NO FLIP-FLOPS** or open toed sandals to be worn when driving!!!
9. Students will only drive during one of the 4 weeks, even though they will have class 3 weeks. Any student who needs extra driving time to pass the driving portion of the class will be scheduled on an individual basis with the driving instructor. Make up driving or extra driving time will probably be scheduled during the second session.
10. IF THE STUDENT HAS TAKEN THE WRITTEN TEST AT THE DMV AND FAILED IT FOUR (4) TIMES, THE STUDENT MUST WAIT AT LEAST 6 MONTHS BEFORE THEY MAY TAKE DRIVER EDUCATION.
11. YOUR DRIVING SCHEDULE WILL BE MAILED OUT TO YOU BEFORE CLASSES BEGIN BY YOUR DRIVING TEACHER.
